

ORDINANCE NO. 3405  
AN APPROPRIATION ORDINANCE AUTHORIZING A REDUCTION IN  
APPROPRIATIONS FROM CERTAIN FUNDS

WHEREAS, the Common Council of the City of New Castle, Indiana passed an annual budget for fiscal year 2004 on September 15, 2003, (Ordinance No. 3371) and

WHEREAS, it has been shown that certain existing appropriations now have unobligated balances that will not be needed for the purposes for which appropriated, thus allowing the aforementioned reductions.
