

ORDINANCE NO. 3443
AN APPROPRIATION ORDINANCE AUTHORIZING A REDUCTION IN
APPROPRIATIONS FROM CERTAIN FUNDS

WHEREAS, the Common Council of the City of New Castle passed an annual budget for fiscal year 2005 on September 20, 2004 (Ordinance Number 3409), and

WHEREAS, it has been shown that certain existing appropriations now have unobligated balances that will not be needed for the purposes for which they were appropriated, thus allowing the aforementioned reductions.
