

ORDINANCE NO. 3502

AN ORDINANCE ESTABLISHING SPEED LIMITS ON HENRY COUNTY ROAD 100  
SOUTH FROM WINTER DRIVE TO FREE ROAD AND AMENDING TITLE VII,  
CHAPTER 74 OF THE NEW CASTLE CITY CODE  
AND MORE SPECIFICALLY AMENDING SCHEDULE V

WHEREAS, this Council is responsible for protecting the public health, safety and general welfare, and

WHEREAS, the regulation of the speed limits on City streets is within the jurisdiction of this Council, and

WHEREAS, this Council has a duty to pedestrians of all ages, and those who operate motor vehicles on the public highways of this City, to establish safe and reasonable speed limits.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that the speed limit on Henry County Road 100 South from Winter Drive to Free Road hereby is changed from forty (40) miles per hour to twenty-five (25) miles per hour.


The penalty for violating this ordinance shall not exceed \$2,500.00 as set forth in Section 70.99 of the New Castle City Code and determination of fine within the limits set forth therein shall be at the sole discretion of the Court based upon the nature and circumstances surrounding the violation. In the event a cited individual acknowledges the violation and wishes to resolve the matter without the necessity of appearing before the New Castle City Court, the fine for violating this ordinance shall be fifty dollars (\$50.00).

**REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon passage and posting of appropriate signage pursuant to the Indiana Manual on Uniform Traffic Safety Control Devices.
