

ORDINANCE NO. 3359  
AN ORDINANCE ESTABLISHING SPEED LIMITS

WHEREAS, the Common Council of the City of New Castle has determined that it is in the best interests of the public safety of the citizens of the City of New Castle to reduce speeds below that which is established by State statute in certain areas and

WHEREAS, it has determined that there in an area within the corporate limits of said City that requires attention and a reduction of speed from that which is by State ordinance established in such areas.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that Chapter 74, Schedule V, Speed Limits, shall be amended by adding one additional 20 mile per hour speed zone. Said new speed zone to be added to said Schedule is as follows:

| <u>STREET</u>    | <u>LOCATION</u>   | <u>SPEED LIMIT</u> |
|------------------|---|--------------------|
| Winter Place Dr. | From the northerly intersection of said street with County Road 100 South throughout its length to the southerly intersection of said street with County Road 100 South (a copy of the plat map is attached hereto and incorporated herein) | 20 mph             |

IT IS FURTHER ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that in addition to the penalties imposed for violation of posted speed limits by the applicable provisions of the Indiana Code, violators of this Ordinance shall also be subject to penalty and fine pursuant to Section 70.99 of the New Castle City Code.

IT IS FURTHER ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that the Street Department of the City of New Castle shall, upon passage of this Ordinance, immediately place speed limit signs reflecting these established zones. Said signs shall be posted in conformity with the Indiana Manual for Uniform Traffic Control Devices.

This ordinance shall take effect immediately upon passage, posting of speed limit signs and publication.

**REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon passage and publication as provided for by law.
