

ORDINANCE NO. # 3333

AN ORDINANCE ESTABLISHING THE SALARIES OF ELECTED CITY OFFICIALS OF THE CITY OF NEW CASTLE, HENRY COUNTY, INDIANA.

PURSUANT TO I.C. 36-4-7-2 ELECTED CITY OFFICERS: FIXING OF ANNUAL COMPENSATION, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE, HENRY COUNTY, INDIANA:

SECTION 1: THAT THE FOLLOWING SHALL BE THE SALARIES FOR THE MAYOR, CLERK TREASURER, CITY JUDGE AND SEVEN COUNCIL MEMBERS EFFECTIVE THE FIRST PAY PERIOD IN JANUARY, 2003. SAID SALARIES ARE HEREBY ESTABLISHED FOR SAID YEAR 2003:

MAYOR.....\$1,558.00 BEGINNING THE FIRST PAY PERIOD JANUARY 2003 AND EVERY TWO WEEKS THEREAFTER.

CLERK TREASURER.....\$1138.00 BEGINNING THE FIRST PAY PERIOD JANUARY 2003 AND EVERY TWO WEEKS THEREAFTER.

CITY JUDGE.....\$ 142.00 BEGINNING THE FIRST PAY PERIOD JANUARY 2003 AND EVERY TWO WEEKS THEREAFTER.

COUNCIL MEMBERS.....\$ 486.00 BEGINNING JANUARY, 2003 AND EVERY MONTH THEREAFTER.

SECTION 2: THAT THE SALARIES ESTABLISHED BY ORDINANCE #2013 DATED APRIL 16, 1973 AS SALARIES PAYABLE FROM THE UTILITY FUNDS PURSUANT TO INDIANA CODE SHALL BE AS FOLLOWS:

MAYOR.....\$ 442.00 BEGINNING THE FIRST PAY PERIOD JANUARY 2003 AND EVERY TWO WEEKS THEREAFTER.

CLERK TREASURER.....\$ 407.00 BEGINNING THE FIRST PAY PERIOD JANUARY 2003 AND EVERY TWO WEEKS THEREAFTER.

SECTION 3: ALL ELECTED OFFICIALS WILL BE ENTITLED TO A HOSPITALIZATION PLAN, PAYING THE SAME PREMIUMS AS ALL OTHER CITY EMPLOYEES, AND A LIFE INSURANCE IN THE AMOUNT OF \$20,000.00, PAYING THE SAME PREMIUMS AS ALL OTHER CITY EMPLOYEES.

SECTION 4: THE CLERK TREASURER IS ORDERED AND DIRECTED TO PUBLISH THIS ORDINANCE TWICE IN A NEWSPAPER OF GENERAL CIRCULATION IN THE ENGLISH LANGUAGE IN THIS CITY. THE FIRST PUBLICATION BEGINS AT LEAST 30 DAYS PRIOR TO THE FINAL PASSAGE OF THIS ORDINANCE.

SECTION 5: THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECTIVE JANUARY 1, 2003 AS PROVIDED BY LAW.

ORDINANCE PURSUANT TO STATE STATUTE.

ALL ORDINANCES IN CONFLICT HERewith ARE HEREBY REPEALED.
