ORDINANCE NO.3390 AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF NEW CASTLE, HENRY COUNTY, INDIANA

This ordinance of the City of New Castle, Henry County, Indiana, is an ordinance to annex certain real estate into its corporate boundaries. It is passed and adopted on the month and year hereinafter stated:

WHEREAS, a petition has been filed with the City of New Castle seeking the annexation of certain territory to said City of New Castle, Henry County, Indiana, and;

WHEREAS, said petition is signed by one hundred percent (100%) of the owners of said territory, and;

WHEREAS, said territory is located outside of, but contiguous to, this municipality, and;

WHEREAS, the owner has indicated a desire to develop said property and in so doing, comply with the laws, rules and regulations of the City of New Castle regarding development.

Section 1: ANNEXATION. NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE, HENRY COUNTY, INDIANA, that the following described real estate shall be annexed into the City of New Castle and shall be a part of said City of New Castle, all pursuant to I.C.36-4-3-5.1. Said real estate being annexed by this ordinance is located in Henry County, Indiana, is contiguous to the current boundaries of the City of New Castle, Henry County, Indiana, and is more particularly described as follows, to-wit:

COMMENCING AT A BRASS PIN AT THE NORTHEAST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION; THENCE ON AN ASSUMED BEARING OF NORTH 89 DEGREES 14 MINUTES 04 SECONDS WEST A DISTANCE OF 1622.13 FEET ALONG THE NORTH LINE OF SAID NORTHEAST QUARTER TO A RAILROAD SPIKE ON THE CENTERLINE OF THE SPICELAND PIKE; THENCE SOUTH 26 DEGREES 34 MINUTES 56 SECONDS WEST A DISTANCE OF 656.89 FEET ALONG THE CENTERLINE OF SAID PIKE TO A P.K. NAIL; THENCE SOUTH 25 DEGREES 41 MINUTES 56 SECONDS WEST A DISTANCE OF 74.82 FEET ALONG THE CENTERLINE OF SAID PIKE TO A P.K. NAIL; THENCE SOUTH 18 DEGREES 58 MINUTES 53 SECONDS WEST A DISTANCE OF 43.12 FEET ALONG THE CENTERLINE OF SAID PIKE TO A P.K. NAIL AT THE SOUTHEAST CORNER OF A CERTAIN 15.00 ACRE TRACT PRESENTLY OWNED BY THE FIRST BAPTIST CHURCH AND TO THE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE SOUTH 18 DEGREES 58 MINUTES 53 SECONDS WEST A DISTANCE OF 107.12 FEET ALONG THE CENTERLINE OF SAID PIKE TO A P.K. NAIL; THENCE SOUTH 14 DEGREES 16 MINUTES 23 SECONDS WEST A DISTANCE OF 75.65 FEET ALONG THE CENTERLINE OF SAID PIKE TO A P.K. Section 3: CURRENT CORPORATE BOUNDARIES. The current definition of the corporate boundaries of the corporate boundaries of the City of New Castle is set forth in Exhibit "A" being a map of said boundaries and Exhibit "B" being a written legal description. Said Exhibits "A" and "B" are attached hereto and made a part hereof.

Section 4: PUBLICATION. Upon passage of this ordinance it shall be published pursuant to the manner prescribed in I.C.36-4-3-7.

Section 5: FILING AND RECORDING. After publication and expiration of the remonstrance period, the Clerk-Treasurer of the City of New Castle shall file and record this ordinance pursuant to the provisions of I.C.36-4-3-22. Section 6: REPEALER. All ordinances or parts of ordinances in conflict herewith are hereby repealed. herein Any provision Section 7: SEVERABILITY: contained which is found by a court of competent jurisdiction to be deemed to be unlawful or which by operation of law shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect. Section 8: EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage and publication as provided for by law.
