- Councilman Peckinpaugh moved to approve the minutes of the last meeting. Council-lady Bertram seconded. Motion carried 7-0

- **#3682 – Golf Cart Ordinance**
President Koger moved to approve Ordinance #3682 on third reading. Councilman Reid seconded. Motion carried 7-0
 - Council-Lady Bertram and Malone requested awareness by all golf cart drivers and authorities regarding children driving the carts. She noted a recent article where 2 young children were severely injured while driving a golf cart.
- **#3683- Elected Officials Salary Ordinance**
President Koger moved to approve Ordinance #3683 on second reading. Councilman Hancock seconded. Motion carried 6-1
- **#3684 – Hourly Employees Salary Ordinance**
President Koger moved to approve Ordinance #3684 on second reading. Council-lady Bertram seconded. Motion carried 7-0
- **#3685 – Management Salary Ordinance**
President Koger moved to approve Ordinance #3685 on second reading. Council-lady Bertram seconded. Motion carried 6-1
- **#3686 – Department of Finance Salary Ordinance**
President Koger moved to approve Ordinance #3686 on second reading. Councilman Peckinpaugh seconded. Motion carried 6-0 with Councilman Reid abstaining.

- **#3688 – Fire Salary Ordinance**
President Koger moved to approve Ordinance #3688 on second reading. Councilman Peckinpaugh seconded. Motion carried 7-0

- **#3689 – EMS Salary Ordinance**
President Koger moved to approve Ordinance #3689 on second reading. Councilman Hancock seconded. Motion carried 7-0
- **#3690 – Amending City Code Title VII CH 74 SCH I**
President Koger moved to approve Ordinance #3690 on second reading. Council-lady Bertram seconded. Motion carried 7-0
 - President Koger moved to suspend the rules to approve Ordinance #3690 on third reading. Councilman Reid seconded. Motion carried 7-0
 - President Koger moved to approve Ordinance #3690 on third and final reading. Council-lady Bertram seconded. Motion carried 7-0
- **#3691 – Outdoor Advertising Fees and Penalties**
President Koger moved to approve Ordinance 3691 on second reading. Council-lady Malone seconded. Motion carried 7-0

OTHER BUSINESS

- President Koger informed Council a new appointee for the EDC Commission was needed. The position has become a lucrative position per state law and the Council's current appointment, Council-lady Bertram cannot serve unless she is willing to give up her Council seat. President Koger moved to appoint Larry Abrams as their representative on the EDC Commission. Councilman Peckinpaugh seconded. Motion carried 7-0

COMMITTEE REPORTS:

- Councilman Hancock requested administration look into the odor in the 300 block area of Bundy Avenue. Mayor York informed Council that it had been flushed both ways by the Wastewater Department and soil samples have been taken.
- Councilman Kidd requested that Cathy Hamilton representing HOPE Initiative present to the Council an update on the grant that was acquired. Ms. Hamilton informed the Council of the phases and steps of a grant and the funding possibilities for it.
- Council-lady Malone requested that Traffic Committee add the following intersections to their agenda;
 - Consider a stop sign at North 7th and Spring and a no outlet or dead end sign at North 8th and Spring
 - No parking on Lincoln Avenue between South 20th and South 21st on one side due to the narrow roadway.
- Councilman Peckinpaugh stated he received a call complaining that the car lot at Edgemont and South 14th was blocking the sidewalks with cars. Chief Catron stated he would look into it.

ADMINISTRATIVE REPORTS:

- Mayor York announced his frustration with citizens showing up at emergency calls and interfering with emergency personnel being able to do their job. He noted that there was a recent fire on a dead end and due to spectators driving into the area the Fire Department had to clear the area before they could begin fighting the fire. Mayor York announced that he has asked the Police Department to begin issuing tickets to these citizens.

CITIZENS APPEARING BEFORE THE BOARD:

- Mrs. Crabtree, New Castle requested information on the stop sign ordinance for Flemming Alley and North 21st Street. After discussion Council suspended the rules and approved Ordinance #3690 on third reading.

- No reports were presented


ADJOURN:
