RESOLUTION NO. 12162013-2

A RESOLUTION DESIGNATING A PORTION OF THE CITY OF NEW CASTLE, INDIANA AS AN ECONOMIC REVITALIZATION AND APPROVING A PERSONAL PROPERTY TAX ABATEMENT

WHEREAS, the Common Council of the City of New Castle, Indiana, now finds that there are various areas and parcels of real estate within the City of New Castle, Indiana, which may be properly designated economic revitalization areas pursuant to IC 6-1.1-12.1-et seg.; and,

WHEREAS, the Common Council of the City of New Castle has been advised by Grede, LLC of a proposed purchase of new manufacturing equipment to be utilized at the facility owned by it within the City of New Castle and has been requested to designate said area commonly known as the Grede Foundry and located at 2700 Plum Street, New Castle, Indiana as described in the legal description and map which are attached hereto as Exhibits "A" and "B" respectfully and incorporated herein by reference as an Economic Revitalization Area under and pursuant to IC 6-1.1-12.1-1 et seq.; and,

WHEREAS, the Common Council of the City of New Castle hereby finds that the area described in Exhibits "A" and "B" is an area which has become undesirable for, or impossible of, normal development and occupancy because of a lack of development, cessation of growth, deterioration of improvements or character of occupancy, age, obsolescence, substandard buildings and other factors which have impaired values or prevented a normal development of property or use of property, and that the designation of said area as an economic revitalization area would enhance the opportunity for appropriate development; and,

WHEREAS, Grede, LLC anticipates increases in the assessed value of its personal property from the proposed purchase of new manufacturing equipment and has submitted documentation, including a statement of benefits, to the Common Council of the City of New Castle in the form attached hereto as Exhibit "C" and incorporated herein by reference; and,

WHEREAS, the Common Council of the City of New Castle has reviewed the statement of benefits included in Exhibit "C" and other information brought to its attention, and hereby determines that it is in the best interests of the City of New Castle to designate the area described in Exhibits "A" and "B" as an economic revitalization area and that the deductions under IC 6-1.1-12.1-3 should be allowed based upon the following findings:

- The estimate of the costs of the real estate rehabilitation and of the new manufacturing equipment is reasonable for such rehabilitation and equipment of the type described;
- The estimate of the number of individuals who will be hired or whose employment will be retained can be reasonably expected to result from the rehabilitation of the real estate and from the installation of the new manufacturing equipment thereon;
- 3. The estimate of the annual wages and salaries of those individuals who will be hired or retained can be reasonably expected to result from the proposed real estate rehabilitation and the installation of new manufacturing equipment;
- 4. That the hiring or retention of said employees and the improvement of the facility and manufacturing process to be realized by Grede, LLC should have a positive effect upon the economy of New Castle, Henry County, Indiana by helping stabilize and improve employment; and

5. The totality of the benefits to be derived by the installation of such new manufacturing equipment is sufficient to justify the deduction created by the approval of tax abatement.

And,

WHEREAS, the Common Council of the City of New Castle hereby finds that the purposes of IC 6-1.1-12.1 are served by allowing the deduction provided by IC 6-1.1-12.1-3 for a period of ten (10) years.

NOW THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that:

- 1. The area described in Exhibit "A" and "B", attached, is designated an economic revitalization area within the meaning of IC 6-1.1-12.1.
- 2. The owner of property within the above-described economic revitalization area shall be entitled to the deduction provided by IC 6-1.1-12.1-3 for a period of ten (10) years with respect to personal property which is contemplated by and reflected in Exhibit "C".
- 3. The statement of benefits submitted by Grede, LLC is hereby approved.
- 4. Notice of the adoption and substance of this resolution and all other disclosures required by IC 6-1.1-12.1-2.5 shall be duly published in accordance with IC 5-3-1, which notice shall state a date for public hearing on this resolution; and that on said date, after hearing objections and remonstrances and considering evidence thereon, this Council will take final action determining whether the qualifications for an economic revitalization area have been met and confirming, modifying and confirming or rescinding this resolution.
- 5. A copy of the above referenced notice and copy of the statement of benefits included in Exhibit "C" hereto shall be filed with the officers of each taxing unit that has authority to levy property taxes in the geographic area which is hereby designated an economic revitalization area at least ten (10) days prior to the public hearing on this resolution.

REPEALER: All resolutions or parts of resolutions in conflict
herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this resolution, to the extent feasible, shall remain in full force and effect.
