

**ORDINANCE NO. 3699**

**AN ORDINANCE AMENDING SECTIONS 91.01, 91.02, 91.03  
OF THE CITY OF NEW CASTLE CITY CODE**

WHEREAS, the New Castle City Code Section 91.01, 91.02, and 91.03 establish rules, regulations and fees for the Westlawn Addition to South Mound Cemetery; and,

WHEREAS, changing demands of the citizens of New Castle require the cemetery to establish rules for above ground cineruriums and columbariums.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL of the City of New Castle, that Sections 91.01, 91.02, and 91.03 of the New Castle City Code shall be amended to allow for the placement of cineruriums and columbariums in Section F, Lots 241 through and including Lot 265.

IT IS FURTHER ORDAINED that an above ground cineruriums and columbariums will be restricted to the following:

- (a) single above ground cineruriums and columbariums shall be restricted to plots consisting of a minimum of \_\_\_\_\_ spaces.
- (b) double above ground cineruriums and columbariums shall be restricted to plots containing a minimum of \_\_\_\_\_ spaces.

IT IS FURTHER ORDAINED that the construction permit provisions of 91.03 shall apply to all cineruriums and columbariums. The cost for permits shall be as follows:

- 1. Single cineruriums and columbariums \$\_\_\_\_\_.
- 2. Double cineruriums and columbariums \$\_\_\_\_\_.

All other provisions of Sections 91.01, 91.02, and 91.03 of the New Castle City Code not changed by this ordinance shall remain in full force and effect.

**REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon passage and publication.
