

ORDINANCE NO.  
**AN ORDINANCE REPEALING ORDINANCE NO. 3724**

**WHEREAS**, it is the responsibility of the Common Council of the City of New Castle to protect and provide for the public, health, safety, and welfare of its citizens and,

**WHEREAS**, it has been determined that it would be in the best interests of public safety to repeal Ordinance No. 3724 and restore certain stop signs removed by said ordinance and remove stop signs established by said Ordinance.

**IT IS THEREFORE ORDAINED BY THE COMMON COUNCIL** of the City of New Castle, that Chapter 74 Schedule 1 of the New Castle City Code shall be amended as follows:

1. Ordinance No. 3724 is hereby repealed.
2. Stop signs shall be restored at the following locations:
  - (a) Street: 9<sup>th</sup> Street  
Location: south and north approaches to Church Street
  - (b) Street: 9<sup>th</sup> Street  
Location: south and north approaches to Vine Street
  - (c) Street: 9<sup>th</sup> Street  
Location: south and north approaches to Spring Street
3. The following stop signs shall be removed:
  - (a) Street: Church Street  
Location: east approach to 9<sup>th</sup> Street

(The above changes restore the stop signs previously removed by Ordinance No. 3724 and removes the stop sign added by Ordinance No. 3724. It is the intent of this council that the traffic control devices at the intersections referred to above be as they were prior to the passage of Ordinance No. 3724.)

4. Penalty: Anyone who violates this ordinance shall be subject to the penalty set forth in Section 70.99 of the New Castle City Code and any violation shall further be reported to the Indiana Bureau of Motor Vehicles for the assessment of points and other penalties that may be applicable pursuant to State law.

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage and publication. Its enforcement may occur after the stop sign referred to above is erected. This ordinance is being enacted pursuant to the authority given the City of New Castle pursuant to I.C. 9-21-1-2 and 9-21-1-3(7).
