ORDINANCE NO.3770

AN ORDINANCE APPROVING AN ADDITIONAL APPROPRIATION OF FUNDS NOT PREVIOUSLY BUDGETED

WHEREAS, the Common Council of the City of New Castle passed an annual budget for fiscal year 2017 on the 17th day of October, 2016 (Ordinance No. 3751); and,

WHEREAS, it has been shown that certain additional funds have now been received that were not previously appropriated and are needed for certain governmental purposes, and those funds are now available to the City from the LOIT Public Safety Fund proceeds; and,

WHEREAS, the monies received from the LOIT Public Safety Fund proceeds have been deposited in the City's LOIT Public Safety Fund, Account 300 and have not been appropriated for any purpose.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE, that certain funds not previously appropriated in the City's 2016 budget (Ordinance No. 3727) are hereby approved for expenditure in 2016 as an additional appropriation. Said additional appropriation is in the sum of \$150,000.00 and shall be set aside in appropriation line 313 Professional Services of the City LOIT Public Safety Fund #300.

In making this appropriation, it is the understanding of the Common Council that said proceeds will be used for the following purpose:

- Purchase of;
 - o 3 2018 Ford Police Interceptor AWD Vehicles
 - o 2 2018 Dodge Charger AWD Vehicle o 6 Vehicle Computers o 5 Vehicles Fully Equipped

 - (Pursuit Safety System)

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon the delivery of a certified copy of same to the Department of Local Government Finance as set forth in I.C. 36-4-7-3 et seq.
