

ORDINANCE NO. 3775

**AN ORDINANCE AMENDING CHAPTER 75, TRAFFIC SCHEDULE IV(B)  
OF THE NEW CASTLE CITY CODE  
ESTABLISHING A ONE-WAY ALLEY**

WHEREAS, the Common Council of the City of New Castle has the duty to protect the public health, safety and welfare; and,

WHEREAS, the Traffic Committee of the Common Council has reviewed the traffic flow on a portion of a certain alley North of Broad Street, South of Vine Street, East of North 16<sup>th</sup> Street and West of North 18<sup>th</sup> Street, and has determined that it should be a one-way alley.

NOW THEREFORE BE IT ORDAINED by the Common Council of the City of New Castle that a portion of a certain alley North of Broad Street, South of Vine Street, East of North 16<sup>th</sup> Street and West of North 18<sup>th</sup> Street should be limited to one-way eastbound traffic.

IT IS FURTHER ORDAINED that Chapter 74 Traffic Schedule IV(B) of the New Castle City Code shall be amended by adding the following:

ALLEY: North of Broad Street and South of Vine Street

LOCATION: from North 16<sup>th</sup> Street on the West to North 18<sup>th</sup> Street on the East

DIRECTION: easterly

(Exhibit "A" attached hereto is made a part of this ordinance.)

IT IS FURTHER ORDAINED by the Common Council that all provisions of Chapter 70 of the New Castle City Code shall apply and more particularly, the penalties set forth in Section 70.99 of said code. Further, if a violator admits to a citation issued pursuant to this chapter, the provisions of Section 70.22(a) 1, 2 and 3 shall apply.

IT IS FURTHER ORDAINED by the Common Council that the Street Department shall posts signs indicating that the portion of the alley described herein is a one-way alley and traffic shall only be permitted to travel in an easterly direction on said alley between North 16<sup>th</sup> and North 18<sup>th</sup> Street.

**REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon passage and publication as provided for by law.
