ADMINISTRATIVE REPORTS:

• Mayor York stated the need for toters has been more demanding as everyone is home and creating more trash, also their water consumption is up. Property taxes are still due on May 11th, but the Governor has issued as order that there will be no late fees or penalties until July 15th. The City is only looking at getting about 20% of their normal tax draw in June and stated that for those that can pay their taxes should go ahead and do so. Thanked everyone for making City business continue to run smoothly and moving forward. Stated that everyone still needs to continue to stay at home as we have 31 cases and only 1 death as of today.

CITIZENS APPEARING BEFORE THE COUNCIL:

- Corey Murphy New Castle Henry County Economic Development asked Council to consider given some money for the revolving loan fund.
- President Peckinpaugh moved to give \$28,000.00 out of the riverboat fund. Seconded by Councilman Dicken. President Peckinpaugh then amended saying that those monies must be used for businesses inside the city limits. Councilman Perdue seconded. Motion carried 7-0.
