

**ORDINANCE NO. 3828**  
**AN ORDINANCE AMENDING SECTION 50.112 OF THE CITY CODE RELATING TO**  
**THE RATES AND CHARGES OF THE SEWAGE WORKS OF THE CITY**

WHEREAS, the City of New Castle, Indiana (“City”) has established, acquired and financed a sewage works pursuant to Indiana Code §36-9-23 and has established rates and charges for the use of the sewage works as set forth in Section 50.112 of the City Code; and,

WHEREAS, the Council has considered the rates and charges currently imposed on residential users that are unmetered as a result of not being connected to the City’s water works; and,

WHEREAS, the Council finds that the charges for unmetered residential customers are greater than necessary and should be adjusted to more accurately reflect the probable use of the sewage works by unmetered residential customers; and,

WHEREAS, the modification of the rates and charges provided by this ordinance will effect approximately thirty six (36) customers of the sewage works and will not have a negative impact upon the City’s ability to operate the sewage works.

NOW THEREFORE BE ORDAINED BY THE COMMON COUNCIL of the City of New Castle, Indiana as follows:

1. Section 50.112(3) is hereby repealed and replaced with the following text:

“3. Unmetered Charge Per Month:

Class I Residential: \$64.69

Class II (Commercial Governmental Institutional): \$124.73

Class III (Industrial): \$124.73”

2. All other provisions of Section 50.112 of the City Code shall remain in full force and effect.

**REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation of law shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon passage and publication as provided for by law.
