

**RESOLUTION #11162015-1**  
**TRANSFERRING FUNDS WITHIN FUNDS**  
**FROM ONE DEPARTMENT BUDGET CLASSIFICATION TO ANOTHER**

WHEREAS, it is necessary to transfer funds from one budget classification to another within the Clerk-Treasurer's Office of the City of New Castle; and

WHEREAS, this transfer does not require the expenditure of more money than the total amount set out in the budget for that Fund.
