AMENDING THE PROVISIONS OF NEW CASTLE CITY CODE SECTION 36.14(A) AND (D) WITH REGARD TO REIMBURSEMENT OF EMPLOYEES FOR USING PERSONAL VEHICLES FOR CITY USE

WHEREAS, the New Castle City Code Section 36.14 provides a provision for the reimbursement of the costs for use of personal vehicles for public business; and,

WHEREAS, Section 36.14 (B) of the said City Code states the following:

"As this amount represents the maximum amount an individual is allowed to receive from his or hers employer for automobile reimbursement, without declaring any portion of that reimbursement as income and without requiring the employer to withhold tax as a result of the reimbursement, that in the event the maximum amount allowable under Internal Revenue Service regulation increases or decreases, that increase or decrease should, after approval by the Board of Public Works and Safety and adoption through resolution by the Common Council, become part of this action."

And,

WHEREAS, the Internal Revenue Service has increased the maximum allowable reimbursement over and above what is currently paid by the City; and,

WHEREAS, this Council is of the opinion that the amount paid to City employees currently is insufficient and should be increased.

NOW, THEREFORE BE IT RESOLVED by the Common Council of the City of New Castle that the employee mileage reimbursement paid by the City to employees using personal vehicles for public use should be increased from the current allowable reimbursement of \$.25 per mile for the first 1,500 miles driven and \$.11 per mile for each additional mile drive on public business while using a personal vehicle to \$.40 per mile with unlimited mileage. That this change should appear as an amendment to rhetorical paragraph (A) and (D) of the New Castle City Code, Section 36.14 found in Title III of said City Code.

All other provisions and sections of New Castle City Code Section 36.14 shall remain in full force and effect.

REPEALER: All ordinances and resolutions or parts of ordinances and resolutions in conflict herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this resolution, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This resolution shall become effective immediately upon passage.
