RESOLUTION OF THE PARK AND RECREATION DISTRICT OF THE CITY OF NEW CASTLE, INDIANA

RESOLUTION NO. 06072021-1

WHEREAS, the Park and Recreation Board ("Board") of the City of New Castle, Indiana ("City") as the governing body of the Park and Recreation District ("District") of the City, at a meeting of the Board held on May 3, 2021, adopted a declaratory resolution ("Declaratory Resolution") describing its purpose to complete the park projects as more fully described in Exhibit A attached hereto and incorporated herein by reference, together with necessary appurtenances, related improvements and equipment (collectively, "Projects");

WHEREAS, the Board gave notice by publication of a hearing to be held on June 7, 2021, which notice was published in *The Courier Times* and stated that a hearing would be held by the Board on this date for the purpose of receiving and hearing remonstrances from persons interested in or affected by these proceedings, including persons owning real or personal property located within the District and persons owning land which may be injuriously affected by these proceedings, and at which hearing the Board would take final action to determine the public utility and benefit of the Projects and the incidental expenses in connection with the Projects and with the issuance of bonds therefor, as described in the Declaratory Resolution;

WHEREAS, the Board on June 7, 2021, held such hearing and received and heard remonstrances from persons interested in or affected by these proceedings and considered the evidence presented at such hearing; and

WHEREAS, the cost of proceeding with the Projects of the District, including any payment to persons owning land which may be injuriously affected by these proceedings and the

incidental costs associated therewith and with the issuance and sale of bonds to provide funds therefor is estimated not to exceed \$1,400,000;

NOW, THEREFORE, BE IT RESOLVED BY THE PARK AND RECREATION BOARD OF THE CITY OF NEW CASTLE, INDIANA, THAT:

Section 1. The Board finds and determines that it will be of public utility and benefit to undertake the proposed Projects, as described in the Declaratory Resolution and confirmed by this Confirmatory Resolution.

Section 2. The estimated cost of all or a portion of the Projects to be funded through the issuance of bonds will not exceed \$1,400,000. The estimated cost includes all necessary expenses to be incurred in connection with the proceedings and the Projects, including a sum sufficient to pay the costs of supervision and inspection during construction and completion, the costs of necessary records, engineering expenses, contingencies, inspections, publication of notices, the issuance and sale of bonds to provide funds for the Projects and expenses and fees incurred in connection therewith and other necessary expenses to be incurred in connection with the letting of contracts with regard to the Projects.

Section 3. In all respects the Declaratory Resolution is hereby confirmed.

Softball diamond upgrades – fence, fields, parking, driveway

Armory/Murphey Park

Pave parking lot

New shelter in the park

Roofing on sections of the armory

New front doors

Floor cleaning machine

Baker Park

Playground expansion between shelter # 1 and #2

Open air shelter New playground equipment Restroom Walkways Additional parking in square parking lot and added parking east of Baker #2

Upgrades for existing shelters

Build new wall at southwest corner of park, include signage

Restroom at Hankenhoff shelter if not built at the softball diamond

Open air shelter near the shuffleboard courts, include walkway

Upgrades on softball diamonds. Build diamond #2 into a varsity field

Upgrade shuffleboard courts and horseshoe facility

Upgrade basketball courts – reseal, lighting, walkway, trash cans

Remove remaining dead trees in the park
