Council President Peckinpaugh stated even though Councilman Koger was not in attendance that Councilman Koger wanted it on record that he was in favor of the following. Council President then stated that he would move that the New Castle City Council supports Greg York, and the Henry County/New Castle Sports Park, application for Food and Beverage Tax money for a sports park and that this support be contingent upon Greg York, and the Henry County/New Castle Sports Park, forming a separate 501(c3) Not for Profit with its own bank account separate from any City of New Castle Finances. I further move that the City Council respectfully as the County Council to make any award to they Henry County/New Castle Sports Park contingent upon the Henry County/New Castle Sports Park obtaining its own 501(c3) Not for Profit status and their own bank account separate from the finances of the City of New Castle. Vice President Hancock seconded.

Council President Peckinpaugh asked for roll call vote.

Councilman Perdue interjected and stated that he fully supports the Sports Park. The Mayor has been taking a temperature to see how people feel about the Sports Park and has gotten a good response. Councilman Perdue was out of town and could not get a hotel room because of the amount of sporting events going on in Bowling Green Kentucky last weekend. Councilman Perdue stated that this could bring a lot of revenue into Henry County and New Castle.

Council President Peckinpaugh asked for roll call vote.

Councilman Dicken interjected and stated he would like to see some kind of feisibility and sustainability study but supports the project and thinks it would be an asset to the community.

Councilman Walden interjected and stated he fully supported the Sports Park and he did a lot of travel ball with his boys and the money they spent for hotel rooms, eating and shopping in other towns and cities really added up. This could be a great thing for Henry County as a whole.

2 times County Councilman Malicoat asked to speak regarding the food and beverage money and was told by Council President Peckinpaugh there would be no public comment. Corey Murphy was allowed to speak as he was on the Committee that scored the projects for the Food and Beverage applications. Council President stated he thought the Committee did not do a good job of vetting the applications. Mr. Murphy continued to speak regarding the process of the vetting and at the end Council President apologized for saying the negative comments about the Committee. Once again County Councilman Malicoat approached the podium and was told to sit down by Council President.
