- Stated the parking lot in the bank of City Hall looks nice.
- Informed everyone that Pam Bliss would be starting on the mural at Citizens Corner on Wednesday and asked that everyone please not bother her as she was working. Val McNelis stated final approval had not yet been given by the Historic Preservation Committee and should she start before that approval. President Peckinpaugh stated that he would look into that.
- Stated that he believes the County is looking to renew the membership into the EIRCP and the City would be responsible for 35 to 36% of the renewal fee. The City and County split the cost 50/50 in 2020 due to Covid and I would like to see us stay in for another two years. There are many good things happened with this program. Councilman Dicken informed everyone that the city cannot join by itself. The County has to join.
- Asked Council to think about possibly changing the amount of the trash toter funds.
 Starting January 1st 2023, he would like to see \$1.50 go into the toter fund and \$1.00 go in to MVH. The on June 1st, 2023 he would like to see \$.50 go into the toter fund and \$2.00 go into MVH.

ADMINISTRATIVE REPORTS:

- Building Commissioner Melton, they would be making a move on the property at 1130 Broad Street. Patty Broyles asked if she could comment on this. President Peckinpaugh asked her to come forward. Mrs. Broyles stated Rose City Partners had tried to purchase this building and were denied. The building is not safe with the bricks falling off the façade, the flooring is not good and the mold. It has been sitting vacate for a year now. The money that has been spent for utilities has cost the County by not selling and could have been taken care of and put back on the tax roles over a year ago.
- Mayor York stated the only thing that he had today was people complaining about 18th street and how long would it be tore up. 18th Street is owned by the state, but he did see they had starting paving it already.
