Building owners would have to put in 10% of the funds. Council needs to do a resolution that they would be in agreement to pay for a Downtown Development Plan. 2010 is the last time one was done and it is out of date thru Brenner Architect. New Castle Mainstreet would have to fundraise \$100,000.00 for 2 years. Attorney Harvey will do the resolution.
- Leanne Mays, read a heartfelt statement thanking Officer Morrison regarding a recent accident she had been involved in. Officer Morrison was in attendance and got a chance to meet with the Mays family during the meeting.
