President Peckinpaugh: Noted;

- Stated, the parks look amazing. So many things going on in the park this weekend. Pickleball was full, people at the skatepark and people playing disc golf. We want it to be very welcoming for anyone to come here.
- Thanked Scott Frost and Everett Cole for heading up the 200 Year Celebration for the city of New Castle. A lot of people attended the family reunion event and several other events that were planned.

ADMINISTRATIVE REPORTS:

- Police Chief Schofield, stated that the Police Officers are dealing with the homeless here in New Castle on a daily basis. They are offering resources as they can but some will not use them or do not want to abide by the rules for them. We are trying to think of some ideas for winter to get them out of the elements. Citizen Jeff Coatie was in attendance and stated that he had first hand seen homeless people die in the streets when he lived in another city and would hope that it would never happen here. President Peckinpaugh stated this is all part of the mental health illness or an addiction they do not want to let go of.
- Fire Chief Moore, stated they Fire Department have started taking applications for a hiring pool again today.
- Cemetery Superintendent Denney, Stated the benches are up not at the columbarium and is looking very nice.
- Director Barker, stated they have started on the ADA sidewalk ramps to get ready for the paving.

- Clerk Treasurer Grider thanked everyone who came out and helped at the Kids Cruise In Saturday night. 165 bikes were given to children at the event and a special thank you was given to the donors who helped make it all possible.
- Mayor York talked about the Hudson's fire and how with all the oil and chemicals that were in the building. Fire fighters lost their turn out gear as some of the oil and chemicals could not be removed. Hoses and Gear that were damaged in the fighting of the fire could not be put back on the trucks for use.

• Clay Morgan asked if there were any current plans for the City to order basketball goals and to construct and operate a City Sports Complex. No one knew of any plans like that. He also questions the non-reverting funds and how they could be used. It was explained that those funds could only be used the for the funds specified. He questioned the use of Fund 278 a sports complex fund and stated he did not see it on Gateway for the year 2022 and received paperwork from the Clerks office on a records request showing that it was on the 2023 Fund List. Clerk Treasurer Grider explained that if it had a zero balance it would not show up on Gateway and that she did not set up a new fund of a sports complex this year. Mr. Morgan confirmed that the\fund was indeed a zero balance and thanked everyone for their time.
