ORDINANCE NO. 3912

AN ORDINANCE AMENDING THE ZONING DISTRICTS OF THE CITY OF NEW CASTLE

WHEREAS, Integrity Land Management, LLC, has requested the New Castle Plan Commission consider an amendment of the master plan of the City of New Castle, as established in Ordinance Number 846, by rezoning certain real estate commonly known as 2001 South Memorial Drive in the City of New Castle from its current C-1 (local business) zoning to C-2 (general business) zoning, and

WHEREAS, in evaluating a proposed rezoning, the Plan Commission and Common Council must give reasonable regard to:

- 1. The comprehensive plan,
- 2. Current conditions and character of the area to be rezoned.
- 3. The most desirable use of the area to be rezoned,
- 4. The property value of the area,
- 5. Reasonable development and growth of the area, and

WHEREAS, on August 16, 2023, the Plan Commission conducted a hearing on the request and voted to certify the request to the Common Council with a favorable recommendation.

NOW THEREFORE BE ORDAINED BY THE COMMON COUNCIL of the City of New Castle, Indiana, that it hereby adopts the recommendation of the New Castle Plan Commission and amends the master plan of the City of New Castle and zoning map by rezoning certain real estate located within the City of New Castle, Henry County, Indiana from C-1 to C-2

A PART OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 21, TOWNSHIP 17 NORTH, RANGE 10 EAST. NEW CASTLE, HENRY COUNTY, INDIANA, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS, TO-WIT:

BEGINNING AT A POINT 1320 FEET SOUTH OF THE NORTHEAST CORNER OF THE NORTHEAST QUARTER OF SECTION 21, TOWNSHIP AND RANGE AFORESAID (WHICH POINT IS ALSO THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION) AND RUNNING THENCE SOUTH ON AND ALONG THE EAST LINE OF SAID QUARTER-QUARTER SECTION, 255.75 FEET; THENCE WEST, 171.95 FEET; THENCE SOUTH, 2.00 FEET; THENCE WEST, 23.65 FEET; THENCE NORTH, 20.50 FEET; THENCE WEST, 24.90 FEET; THENCE NORTH, 96.00 FEET; THENCE EAST, 9.40 FEET; THENCE NORTH, 144.50 FEET TO THE NORTH LINE OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION; THENCE EAST, 211.10 FEET TO THE PLACE OF BEGINNING, SAID ABOVE DESCRIBED TRACT CONTAINING 1.2622 ACRES, MORE OR LESS.

EXCEPT:

A PART OF THE NORTHEAST QUARTER OF SECTION 21, TOWNSHIP 17NORTH, RANGE 10 EAST, HENRY COUNTY, INDIANA, DESCRIBED AS FOLLOWS:

BEGINNING AT THE INTERSECTION OF THE SOUTH BOUNDARY OF MIDWAY DRIVE AND THE WESTERN BOUNDARY OF S. R. 3 A DISTANCE OF 1,350.00 FEET SOUTHERLY (ALONG THE EAST LINE OF SAID QUARTER SECTION) AND NORTH 89 DEGREES 00 MINUTES 00 SECONDS WEST, 21.40 FEET (ALONG THE SOUTH BOUNDARY PROLONGED, OF SAID MIDWAY DRIVE) FROM THE NORTHEAST CORNER OF SAID QUARTER SECTION; THENCE SOUTHWESTERLY, 39.84 FEET ALONG SAID WESTERN BOUNDARY OF S. R. 3; THENCE NORTH 34 DEGREES 40 MINUTES

28 SECONDS WEST, 48.14 FEET TO THE SOUTH BOUNDARY OF MIDWAY DRIVE; THENCE SOUTH 89 DEGREES 00 MINUTES 00 SECONDS EAST, 35.67 FEET ALONG SAID SOUTH BOUNDARY TO THE POINT OF BEGINNING AND CONTAINING 0.016 ACRE, MORE OR LESS.
