

## BOARD OF WORKS

March 4, 2024 at 10:00 a.m.

The meeting was called to order by Mayor York

Attendance: Present: Mayor York, Director Barker, Attorney Harvey

### **CITIZENS APPEARING:**

- Richard Petty of Mad Hyena Bar came before the board to request help/guidance for a mural dedication he is having at his location on June 29<sup>th</sup> at 1:00pm. This is a "We the People" mural and it is being dedicated to Veteran's. He stated that Veterans are going to be flying in from all around the world to attend this event. He is expecting at least 5,000 people. There will also be a ribbon cutting that will take place. Mayor York stated that he would like Mr. Petty to keep in touch with the Mayor's Office closer to time of this event.
- Chief Moore and the NCFD were present for the swearing in of newly hired fireman Ryan Leeka. Clerk-Treasurer Ashley Huffman officially swore him in and welcomed him to the NCFD.

- The 2024 Main Street Banner scheduled was presented for approval. KareMar Designs, Marlin Evans, has taken care of this in the past and the schedule has not changed. Mayor York moved to approve as presented. Director Barker seconded. Motion carried 3-0.

### **DEPARTMENT HEAD REPORTS:**


- Chief Schofield stated that on Monday, May 13<sup>th</sup> the EMA office will be holding an active shooter training at the old courthouse. There will be two sessions in the morning and two sessions in the afternoon. They are requesting 12<sup>th</sup> street to be shut down from Broad to Church Street. They may also ask the Senior Center to close for the day since they are directly across the street from the training.
- Director Barker noted that the lift station on 20<sup>th</sup> street will be worked on from Tuesday-Friday this week. The blocks from California & Virginia Street will be closed for this maintenance. Emergency services please plan accordingly.

- Steve Dickerson, Certified Superintendent of the Waste Water Plant, expressed his concerns over the lift station on Commerce Drive and the excessive amount of grease and oil that is creating problems. Director Barker stated that the Utility Impact Board had discussed this issue previously and requested Steve and Zed Leath, Assistant Superintendent to attend the next UIB meeting to discuss further.
- Mayor York stated that the Solar Eclipse is just a month away, Monday, April 8<sup>th</sup>. There is a full slate of events for that weekend leading up to that Monday.




