ORDIANANCE #3953

AN ORDINANCE RESTATING AND AMENDING THE SCHEDULE OF FEES FOR NEW CASTLE SOUTH MOUND CEMETERY AND WESTLAWN ADDITION

WHEREAS, Chapter 91.01(B) of the City Code establishes rates and charges for burial space and burial in the South Mound Cemetery; and

WHEREAS, the fees and charges for burial space and burial should be restated and new rates for columbarium placement on Saturday should be added.

NOW THEREFORE BE IT ORDAINED by the Common Council of the City of New Castle, Indiana, that Chapter 91.01 (B) of the City Code shall read as follows:

1. Chapter 90.01(B)(1) shall read as follows:

Gravesite charges and fees:

- a. Each gravesite without a foundation: \$800.00;
- b. Each gravesite with a foundation: \$1,000.00;
- c. A gravesite "baby land": \$125.00;
- d. Mausoleums: \$5,200.00
- 2. Chapter 90.01(B)(2) shall read as follows:

Opening and closing fees:

- a. In ground burials: \$800.00;
- b. In ground cremains: \$400.00;
- c. Burial in "baby land": \$200.00;
- d. Baby or infant in other areas: \$700.00;
- e. Mausoleum: \$400.00
- 3. Chapter 91.01(B)(3) shall read as follows:

Miscellaneous additional fees or increased charges for Saturday burial:

- a. Saturday burials:
 - 1. Cremains burials before noon: \$550.00;
 - 2. Cremains burials after noon: \$600.00;
 - 3. Burials before noon: \$1,200.00
 - 4. Burials after noon: \$1,250.00
 - 5. Burials in "baby land" before noon: \$350.00
 - 6. Burials in "baby land" after noon: \$450.00
 - 7. Columbarium: \$100.00 (additional charge)
 - 8. Baby or infant in other areas before noon: \$1,100.00

2. Disinterr	ment after noon: \$2,000.00;
3. Disinterr	ment of cremains before noon: \$800.00
4. Disinterr	ment of cremains after noon: \$1,000.00
