**UPDATE ON DO DA'S AND RAIN'S PLUMBING LETTERS:** Dave C. sent letters to Do Da's Plumbing and Rain's Plumbing dated April 8<sup>th</sup> and April 9<sup>th</sup>, respectively. The letters demanded payment of past charges within 14 days, failure to comply will result in litigation to recover money owed.

**UPDATE ON INCREASING DEPOSIT AMOUNTS FOR SEWER/WATER SERVICE:** Janice reported she had contacted the City of Rushville and was told their water service deposit is \$75 for residential and higher for commercial (amount variable depending on the type of business), and she contacted the City of Connersville and was told the combined water/sewer deposit is \$145 for residential.
