- President Koger moved to approve the minutes of the last meeting. Councilman Peckinpaugh seconded. Motion carried 5-0

### **ORDINANCES:**

- **#3678 – Amending Ordinance #3172 – Purchasing Ordinance**  
President Koger moved to approve Ordinance #3678 on second reading. Councilman Hancock seconded. Motion carried 5-0
- **#3679 – Establishing an additional no parking zone – North 14<sup>th</sup> Street**  
Councilman Hancock moved to approve Ordinance #3679 on second reading. Councilman Reid seconded. Motion carried 5-0
- **#3680 – Establishing a Promotional Fund**  
President Koger moved to approve Ordinance #3680 on second reading. Councilman Peckinpaugh seconded. Motion carried 5-0
- **#3681 – 2014 City Budget**  
President Koger read and moved to approve Ordinance #3681 on first reading. After discussion and a request that the Clerk Treasurer correct the EDC contract amount, Councilman Peckinpaugh seconded. Motion carried 4-0-1 with Councilman Reid abstaining.

### **OTHER BUSINESS**

- No other business was presented.

### **COMMITTEE REPORTS:**

- Councilman Hancock requested information on the outlet boxes on Broad Street where the trees had been removed. Mayor York informed Council that the boxes were

scheduled to be reset.

- Councilman Reid requested information on the sidewalk maintenance being conducted at Mourer and Bundy. Mayor York informed that the city had deemed it unsafe and was repairing it. Councilman Reid requested the Sidewalk Replacement Program be reviewed as to reinstating it.
- Councilman Peckinpaugh requested information on the Golf Cart Ordinance and its timing. After discussion by the Council Councilman Peckinpaugh agreed to be the point of collection for the Council and forward to Attorney Copenhaver. It was decided that the first reading of the ordinance would be scheduled for the September 3 meeting.

**ADMINISTRATIVE REPORTS:**

- Mayor York informed Council that all 4 contracts had been negotiated and signed, with a 4% wage increase across the board for all employees, noting there was a reclassification done with municipal and management employees to reduce the number of different pays down to 5 in each area.
