

**ORDINANCE NO. 3669**

**AN ORDINANCE AMENDING NEW CASTLE CITY CODE TITLE VII,  
CHAPTER 74, SCHEDULE I**

WHEREAS, the intersection of Indiana Avenue and South 22<sup>nd</sup> Street is currently controlled by stop signs on Indiana Avenue as it approaches South 22<sup>nd</sup> Street from the east and west; and,

WHEREAS, due to the closing of South 22<sup>nd</sup> Street where it crosses the railroad tracks north of Indiana Avenue, it has been determined that it is in the best interest of public safety that the stop signs on Indiana Avenue be removed and the intersection controlled by a stop sign on South 22<sup>nd</sup> Street as it approaches Indiana Avenue from the south.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL of the City of New Castle, that Title VII, Chapter 74, Schedule I of the New Castle City Code is hereby amended as follows:

1. DESIGNATION OF STOP STREET: South 22<sup>nd</sup> Street
2. LOCATION: South approach to Indiana Avenue.
3. REMOVAL OF EXISTING SIGN: The existing stop signs located on Indiana Avenue at its east and west approaches to South 22<sup>nd</sup> Street should be removed.
4. PENALTY: One who violates this ordinance shall be subject to the penalty set forth in Section 70.99 of the New Castle City Code and any violation shall be further reported to the Indiana Bureau of Motor Vehicles for the assessment of points and other penalties that may applicable pursuant to state law.

**REPEALER**: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY**: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE**: This Ordinance shall become effective immediately upon passage and publication. Its enforcement may occur after the stop signs referred to above currently located on Indiana Avenue are removed and the stop sign on South 22<sup>nd</sup> is properly erected.

This ordinance is being enacted pursuant to the authority given the City of New Castle pursuant to I.C. 9-21-1-2 and 9-21-1-3(7).
