

ORDINANCE NO. 3691

**AN ORDINANCE ESTABLISHING FEES AND PENALTIES
REGARDING OUTDOOR ADVERTISING SIGNS**

WHEREAS, on May 29, 2001, the Common Council of the City of New Castle, Indiana adopted Ordinance 3265, an ordinance regarding the regulation of outdoor advertising signs; and,

WHEREAS, said ordinances established certain filing fees and penalties with regard to the permitting process of said signs; and,

WHEREAS, it has been determined by the Common Council that a new schedule of fees and penalties should be adopted.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL of the City of New Castle, that the sign fees for permits for the various types of outdoor advertising signs are hereby established in accordance with Exhibit "1" attached hereto incorporated herein, and made a part hereof.


IT IS FURTHER ORDAINED that the penalties for failure to obtain permits is also established and set forth in Exhibit "1".

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage and publication.


