

**A RESOLUTION NO. 1222013-1**  
**A RESOLUTION CORRECTING CERTAIN SCRIVENER'S**  
**APPEARING THE 2014 SALARY ORDINANCE**

WHEREAS, the Common Council of the City of New Castle did on October 21, 2013, pass Ordinance Number 3684, which established certain salaries for positions within the City of New Castle; and,

WHEREAS, it has been determined that certain scrivener's errors and omission occurred resulting in the need to correct that ordinance by resolution.

NOW THEREFORE BE IT RESOLVED by the Common Council of the City of New Castle, that certain errors or omission appearing in Ordinance Number 3684, the same being the 2014 Salary Ordinance for the City of New Castle, Indiana passed on October 21, 2013, shall be corrected. Said corrections are as follows:

1. The position of laborer at the hourly rate of \$14.20 should be added as a position available for all departments.
2. The position of mechanics at \$15.78 hourly should be added to the Public Works Department.
3. The correct hourly rate for mechanics helper appearing in the Public Works Department is \$15.31.
4. The Water Works Certification paragraph should be corrected to read as follows: "Upon acquiring certification from the Indiana State Board of Health certified employees will receive one (1) certification pay increase in each group listed as follows:" (The words "in each group listed" were omitted inadvertently from the original ordinance.)

All provisions of Ordinance Number 3684 not corrected by this resolution shall remain unchanged and in full force and effect as originally adopted by this Common Council.

**REPEALER:** All resolutions or parts of resolutions in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this resolution, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This resolution shall become effective immediately upon passage.
