CITIZENS APPEARING BEFORE THE COUNCIL:

- Teresa King presented to the Council;
 - her concern regarding the rate increase and the impact it would have on fixed income households;
 - o update on her request for review of a stop sign at North 8th and Spring Streets.
 - Chief Catron informed her the police department did a multiple day review and only found one incident where a car was clocked at 31 mph and the speed limit was posted 30 mph, that they had found no issue with the intersection.
 - Reported the house next door to her needed mowed. Mayor York informed her to report it to the Building Inspectors Office.

- Eddie Hager passed out and read a statement of his concern for the upkeep, maintenance and mowing of the Cemetery.
- Robert Dye, Parks Department Employee introduced himself to all in attendance and informed Mr. Hager that his statements, although directed at the Mayor were critiquing the employees and their performance in dealing with the mowing issues of the cemetery and park, noting that this was not a new issue, that every administration dealt with this issue and had the agreement of former Mayor's Bud Ayers, Tom Nipp and Jim Small who were in attendance. He informed Mr. Hager and Council that he personally spends a full 8 hours, weather permitting, on a mower from mid-April to as late as November trying and keep up with the mowing issue. That he would gladly donate a Saturday to assist the Cemetery employees and hoped others were as generous.
- Cathy Hamilton informed Council and all in attendance that Saturday June 21st from 1pm to 6pm was the Annual Garden Tour.
- Norma Dishman stated her concern that Councilman Reid's suggestion to be more
 aggressive with the rate increase was not considered by Council. After discussion Mrs.
 Dishman stated that she agreed with Mrs. King that a rate increase would be hard for the
 fixed income citizens of New Castle, that most cannot afford insurance, how were they
 expected to afford an increase.
