ORDINANCE NO. 3702

AN ORDINANCE ENACTING AND ADOPTING CURRENT AND ALL PRIOR SUPPLEMENTS TO THE CODE OF ORDINDANCES OF THE CITY OF NEW CASTLE, STATE OF INDIANA AND DECLARING AN EMERGENCY

WHEREAS, American Legal Publishing Corporation of Cincinnati, Ohio has completed the current supplement to the Code of Ordinances of the City of New Castle, which supplement contains all ordinances by general and permanent nature enacted since the prior supplement to the Code of Ordinances of the City of New Castle; and,

WHEREAS, the American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinance which are based on or made reference to sections of the Indiana Code; and,

WHEREAS, it is the intent of the Common Council of the City of New Castle to accept these updated sections and all prior updated sections in accordance with the changes of law of the State of Indiana; and,

WHEREAS, it is necessary to provide for the usual daily operation of the municipality and for the immediate preservation of the public peace, health, safety and general welfare of the municipality that this ordinance take effect immediately upon passage.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL of the City of New Castle, Indiana as follows:

- $\underline{\text{Section 1}}$. That the 2014 S-17 supplement of the Code of Ordinances of the City of New Castle as submitted by American Legal Publishing Corporation of Cincinnati, Ohio, be and the same is hereby adopted by reference as if it is set out in its entirety.
- $\underline{\text{Section 2}}$. That all prior supplements to the Code of Ordinances of the City of New Castle as submitted are also hereby adopted as set out in their entirety.
- Section 3. This ordinance is intended to conform with all requirements of I.C. 36-1-5-1 et seq. and two copies of the Code of Ordinances are to be kept on file in the office of the Clerk-Treasurer of the City of New Castle and are available for public inspection.
- $\underline{\text{Section 4}}$. The current Supplement shall be deemed published as of the day of its adoption and approval by this Common Council and the Clerk-Treasurer of the City of New Castle is hereby authorized and ordered to insert such Supplements and all prior Supplements into the Code of Ordinances kept on file in her office.
- $\underline{\text{Section 5}}$. This ordinance is declared to be an emergency measure necessary for immediate preservation of the peace, health, safety and general welfare of the people of the City of New Castle and shall take effect immediately upon passage.
- **REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.
