## ORDINANCE NO. 3406 AN ORDINANCE PROHIBITING LEFT TURNS AT A CERTAIN INTERSECTION

WHEREAS, it is the responsibility of the Common Council of the City of New Castle to provide for the public health, safety and welfare of the citizens of the City of New Castle, and

WHEREAS, in carrying out this responsibility, the Traffic Committee of said Council has determined that improved traffic control and highway safety warrant the prohibition of left hand turns from eastbound I Avenue onto northeasterly Grand Avenue.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that its Traffic Code Title VII of the New Castle City Code, is amended by adding the following left turn prohibition:

"Eastbound traffic on I Avenue shall be prohibited from turning left at the intersection of I Avenue and Grand Avenue in the City of New Castle, Indiana."

IT IS FURTHER ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that the New Castle Street Department shall immediately, upon passage of this Ordinance, install the appropriate "no left turn" signage to carry out the intent of this ordinance and properly inform the motoring public. Said sign shall be placed on I Avenue as it approaches the intersection of said avenue with Grand Avenue. Said signage and its location shall conform with the provisions of the Indiana Manual on Uniform Traffic Control Devices.

IT IS FURTHER ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that in addition to the penalties imposed for violation of properly erected traffic control devices and signs by the applicable provisions of the Indiana Code, violators of this ordinance shall also be subject to penalty and fine pursuant to Section 70.99 of the New Castle City Code.

 $\underline{\text{REPEALER}}\colon$  All ordinances or parts of ordinances in conflict herewith are hereby repealed.

 $\frac{\text{SEVERABILITY}}{\text{found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.}$ 

 $\underline{\text{EFFECTIVE DATE}}\colon \text{ This Ordinance shall become effective immediately upon passage, publication, and proper posting of the directional sign referred to above, all as provided for by law.}$
