ORDINANCE NUMBER 3414 AN ORDINANCE ADOPTING THE CITY OF NEW CASTLE SEWER USE ORDINANCE AND AMENDING TITLE V CHAPTER 50 OF THE NEW CASTLE CITY CODE

WHEREAS, federal and state regulations regarding the operation and maintenance of a city's wastewater facility and the processing of wastewater is in a state of constant change and revision, and

WHEREAS, from time to time the City of New Castle must amend its sewer use ordinance in order to comply with these ever changing state and federal regulations, and

WHEREAS, these changes are mandated by state and federal law, and

WHEREAS, the changes are often comprehensive making individual provision changes cumbersome and impracticable, and

WHEREAS, it is the desire of the City of New Castle to comply in all respects with the requirements of the State of Indiana as imposed by the Indiana Department of Environmental Management (IDEM) and the United States Government as imposed by the Environmental Protection Agency (EPA), and

WHEREAS, it is in the best interest of the health and safety of the citizens of the City of New Castle to have a current and effective sewer use ordinance,

NOW THEREFORE IT IS ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that Chapter V Section 50 of the City Code is hereby amended and the City hereby adopts the attached standards and names them the City of New Castle Sewer Use Said Sewer Use Ordinance is attached hereto, Ordinance. incorporated herein and made a part hereof.

Any portions of the aforementioned Chapter ${\tt V}$ Section 50 not amended, repealed, or superceded by this Ordinance shall remain in full force and effect.

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage and publication as provided for by law.
