

ORDINANCE NO. 3353
AN ORDINANCE ESTABLISHING BUS STOP

WHEREAS, the Board of Public Works and Safety pursuant to New Castle City Code, Section 72.09(A) did at its regular meeting of February 24, 2003, designate the north side of Church Street from the east drive of Maplewood Terrace east to the west curb line of South Fifteenth Street as a bus stop, said designation to be effective from 7:00 a.m. to 5:00 p.m. Monday, Tuesday, Wednesday, Thursday and Friday, and

WHEREAS, this Council should amend New Castle City Code, Chapter 75, Schedule V to reflect this designation:

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL of the City of New Castle that the following designated bus loading zone shall be added to Chapter 75, Schedule V of the New Castle City Code:


IT IS FURTHER ORDAINED BY THE COMMON COUNCIL of the City of New Castle that a violation of this ordinance shall subject the violator to the penalties prescribed by New Castle City Code Section 72.99(C). That as set forth in said provision, the violator is subject to a fine of not less than \$15.00 nor greater than \$250.00 and further that this is designated as a towing zone and any violator is responsible for the costs of towing and storage of an improperly parked vehicle. A separate offense shall be deemed committed on each day that a violation occurs or continues.

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage.
