

ORDINANCE NO. 3358

AN ORDINANCE AMENDING CHAPTER 75, SCHEDULE IV  
OF THE NEW CASTLE CITY CODE ENTITLED,  
"PARKING TIME LIMITED"

WHEREAS, it has been determined that a new location should be added as a "Limited Parking Zone" to Chapter 75, Schedule IV of the New Castle City Code;

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL of the City of New Castle that the following location shall have limited parking and be added to Schedule VI, Chapter 75 of the New Castle City Code and shall designated as a "30 minute parking zone".

<u>Street</u>	<u>Side</u>	<u>Location</u>
North 6th	West	commencing at a point 80 feet north of the curb line of the intersection of the north side of Broad Street and the west side of 6 <sup>th</sup> Street, continuing north a distance of 65 feet to the intersection of the west curb line of north 6 <sup>th</sup> Street and the south curb line of a certain alley which intersects therewith.

TIME LIMIT: 30 Minutes

PENALTY:

The penalty for violation of this ordinance shall be as follows:

"Whoever violates this ordinance shall have their vehicle towed and impounded as provided for in New Castle City Code Sections 72.40 and 72.41 and be fined according to the following:

- (a) shall be assessed a fine of not less than \$50.00 or more than \$250.00;
- (b) This ordinance incorporates herein by reference the provisions of Section 72.99 (A), which provides that a separate offense shall be deemed committed on each day that a violation occurs or continues, and Section 72.99 (D) which provides that a violator of this ordinance shall be responsible for the costs incurred in towing the improperly parked vehicle and storage thereof. The violator shall also be responsible for costs incurred in prosecuting the action for improper parking which shall include, but not be limited to, court costs."
- (c) Failure to pay a citation issued hereunder imposes the provisions of New Castle City code Section 72.99(H).



This ordinance shall become effective immediately upon passage of publication.

**REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon passage and publication as provided for by law.
