

ORDINANCE NO. 3742

AN ORDINANCE ESTABLISHING PARK SHELTER RENTAL FEES

WHEREAS, the City of New Castle has shelter facilities in its City parks, and,

WHEREAS, members of the public may rent these facilities, and,

WHEREAS, a rental fee should be established for their use.

NOW THEREFORE BE IT ORDAINED by the Common Council of the City of New Castle that the following rental fees are established for the park rental structures:

- (a) Rental fee for residents of the City of New Castle: \$35.00 for one (1) day rental or any portion of one (1) day rental;
- (b) \$50.00 rental fee for non-residents of the City of New Castle for any one (1) day rental or any portion of one (1) day;

IT IS FURTHER ORDAINED by the Common Council that the Board of Public Works and Safety in consultation with the New Castle Park Board shall establish rules and regulations regarding the use and rental of these facilities including but not limited to the development of a rental agreement form, establishment of rental fee payment procedure, establishment of cleaning costs or damage deposit requirements, and other rules, requirements and regulations regarding the use of park shelter structures.

IT IS FURTHER ORDAINED by the Common Council that one hundred percent (100%) of all fees generated by the rental of shelter structures shall be deposited in the "Park Department Non-Reverting Fund" as established by Ordinance No. 3309 adopted by this Council on February 4, 2002.

**REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon passage.
