
**CITIZENS APPEARING BEFORE THE COUNCIL:**

- Cathy Hamilton, New Castle, informed Council of the upcoming EDC Summit in Muncie scheduled for June 7.


**DEPARTMENT HEAD REPORTS:**


- Ed Hill updated Council on the BEP Grant noting bids had been processed on Round 1, Group 3.
