## ORDINANCE NO. 3748

## AN ORDINANCE APPROVING AN ADDITIONAL APPROPRIATION OF FUNDS NOT PREVIOUSLY BUDGETED

WHEREAS, the Common Council of the City of New Castle passed an annual budget for fiscal year 2016 on the  $19^{\rm th}$  day of October, 2015 (Ordinance No. 3727); and,

WHEREAS, it has been shown that certain additional funds have now been received that were not previously appropriated and are needed for certain governmental purposes, and those funds are now available to the City from the Riverboat proceeds; and,

WHEREAS, the monies received from the LOIT Public Safety Fund proceeds have been deposited in the City's LOIT Public Safety Fund, Account 300 and have not been appropriated for any purpose; and,

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE, that certain funds not previously appropriated in the City's 2016 budget (Ordinance No. 3727) are hereby approved for expenditure in 2016 as an additional appropriation. Said additional appropriation is as follows:

From LOIT Public Safety Fund No. 300: \$168,584.00 To City Payroll Fund No. 701: \$168,584.00

In making this appropriation, it is the understanding of the Common Council that said fund will be used to pay employees of the City Public Safety Departments of Police, Fire and EMS, incentive pay during calendar year 2016. That incentive pay will be as follows:

All full time employees of the City Public Safety Departments of Police, Fire and EMS shall receive the following incentive pays;

 September 2016
 \$1,000.00

 December 2016
 \$1,000.00

**REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon the delivery of a certified copy of same to the Department of Local Government Finance as set forth in I.C. 36-4-7-3 et seq.
