

ORDINANCE NO. 3761

AN ORDINANCE AMENDING ORDINANCES
NUMBERED 3729, 3730, 3731, 3732, 3733, AND 3734

AN ORDINANCE AMENDING THE ORDINANCES WHICH ESTABLISHED THE SALARIES OF THE FOLLOWING DEPARTMENTS WITHIN THE CITY OF NEW CASTLE:

- (1) HOURLY WORKERS;
- (2) DEPARTMENT OF FINANCE;
- (3) ADMINISTRATIVE AND MANAGEMENT EMPLOYEES;
- (4) POLICE DEPARTMENT;
- (5) FIRE DEPARTMENT; AND,
- (6) EMS WORKERS

WHEREAS, the Common Council established the salaries and benefits of:

- (1) Hourly Salaried Workers by passing Ordinance No. 3734;
- (2) Department of Finance workers by passing Ordinance No. 3730;
- (3) Administrative and Management salaries by passing Ordinance No. 3729;
- (4) Police Department salaries by passing Ordinance No. 3731;
- (5) Fire Department salaries by passing Ordinance No. 3732; and,
- (6) EMS salaries by passing Ordinance No. 3733; and,

WHEREAS, it has been determined that said ordinances must be amended.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE that the following ordinances are amended as follows:

1. Ordinance 3734 is hereby amended to provide that special duty pay in the Building Inspector's Department shall be as follows:
 - (a) Planning Commission secretary \$300.00 yearly;
 - (b) Board of Zoning Appeals secretary \$300.00 yearly; and,
 - (c) License Board secretary \$300.00 yearly.
2. Ordinance 3730 is hereby amended as follows:
 - (a) Termination of Insurance Claims Investigator/Processor position as of 10-10-2016 and create as of 10-10-2016 Payroll Administrator;
 - (b) Annual employee incentive award to be paid no later than September 30, 2016, of \$500.00.
3. Ordinance 3729 is hereby amended as follows:
 - (a) Annual employee incentive award to be paid no later than September 30, 2016, of \$500.00.
 - (b) Annual employee incentive award no later than September 30, 2016, for police chief, assistant police chief, fire chief, battalion chief, an EMS chief of \$1,000.00 and a second award of \$1,000.00 no later than December 30, 2016, for a total of \$2,000.00 for the year.
4. Ordinance 3731, 3732, and 3733 are amended as follows:
 - (a) Annual employee incentive award no later than September 30, 2016, of \$1,000.00 and a second award of \$1,000.00 no later than December 30, 2016, for a total of \$2,000.00 for the year.

All other provisions of Ordinances No. 3729, 3730, 3731, 3732, 3733, and 3734 not amended by this ordinance shall remain in full force and effect.

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage and publication as provided for by law.
