ORDIANANCE #3860

AN ORDINANCE AMENDING THE SCHEDULE OF FEES FOR NEW CASTLE SOUTH MOUND CEMETERY AND WESTLAWN ADDITION

WHEREAS, Chapter 91.01(B) of the City Code establishes rates and charges for burial space and burial in the South Mound Cemetery; and

WHEREAS, the fees and charges for burial space and burial are no longer adequate and should be increased.

NOW THEREFORE BE IT ORDAINED by the Common Council of the City of New Castle, Indiana, that Chapter 91.01 (B) of the City Code shall be amended as follows:

1. Chapter 90.01(B)(1) shall be amended as follows:

Gravesite charges and fees:

- a. Each gravesite without a foundation: \$700.00;
- b. Each gravesite with a foundation: \$900.00;
- c. A gravesite "baby land": \$125.00.
- 2. Chapter 90.01(B)(2) shall be amended as follows:

Opening and closing fees:

- a. In ground burials: \$700.00;
- b. In ground cremains: \$375.00;
- c. Burial in "baby land": \$200.00.
- 3. Chapter 91.01(B)(3) shall be amended as follows:

Miscellaneous additional fees or increased charges for Saturday burial:

- a. Saturday burials:
 - 1. Cremains burials before noon: \$450.00;
 - 2. Cremains burials after noon: \$550.00;
 - 3. Burials before noon: \$1,100.00

- 4. Burials after noon: \$1,200.00
- 5. Burials in "baby land" before noon: \$350.00
- 6. Burials in "baby land" after noon: \$450.00
- b. Disinterment charges:
 - 1. Disinterment before noon: \$1,900.00;
 - 2. Disinterment after noon: \$2,000.00;
 - 3. Disinterment of cremains before noon: \$800.00
 - 4. Disinterment of cremains after noon: \$1,000.00

c. An additional charge of \$300.00 will be imposed for any burial or disinterment beginning after 3:30 p.m.

d. A charge of \$75.00 shall be imposed for any non-standard records work or recording of records.

e. No Sunday or holiday burials shall be permitted.

Any provision of Chapter 91.01 of the City Code, which is not expressly amended by this Ordinance, shall remain in full force and effect.

<u>REPEALER</u>: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

<u>SEVERABILITY</u>: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation of law shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective on June 1, 2021.
