

**ORDINANCE NO. 3866**

**AN ORDINANCE AMENDING PRIOR ORDINANCES REGARDING THE  
SCHEDULING OF CHARGES FOR THE EMERGENCY AMBULANCE AND  
TRANSPORTATION SERVICES**

WHEREAS, the City of New Castle has by the passage of prior ordinances (See Ordinance 3416 passed on January 5, 2005; Ordinance 3539 passed May 19, 2008; Ordinance 3569 passed May 18, 2009; Ordinance 3594 passed March 15, 2010; Ordinance 3712 passed December 1, 2014; and

WHEREAS, said charges have been codified in Section 33.26 of the New Castle City Code; and,

WHEREAS, it has been determined that the scheduled charges are currently inadequate and should be increased.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL of the City of New Castle, Indiana that Section 33.26 and all ordinances amended herein establishing charges should be and hereby are amended as follows:

| 5. | Specialty Care Transport | \$2,000.00              |
| 6. | BLS Non-Emergency        | \$800.00                |
| 7. | BLS Emergency            | \$950.00                |

All other provisions of Section 33.26 of the New Castle City Code, Ordinances Numbered 3416, 3539, 3569, 3594 and 3712 not changed by this amendment, shall remain in full force and effect.

**REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon passage and publication as provided for by law.
