CITIZENS APPEARING:

Motion carried 3-0.

- A Community Paramedic Service Agreement was presented for approval, as where the New Castle EMS will do the community paramedic service for the Henry Community Health Hospital and in return the New Castle EMS will receive \$100,000.00 Annually. Mayor York moved to approve. Director Barker seconded. Motion carried 3-0.
- A revised Opioid agreement to opt back in was presented for approval. Mayor York moved to approve. Director Barker seconded. Motion carried 3-0.

DEPARTMENT HEAD REPORTS:

- Assistant Chief Moore announced that Firefighter Chris Cole would be retiring.
- Assistant Chief Moore presented quotes for new air bottles as the fire department has a lot of expired bottles that need replaced. 10 air tanks are needed Donley Safety quote was \$10,885.20. 5 Alarm Fire and Rescue quote was \$11,565.61. Mayor York moved to approve the purchase from Donley Safety. Director Barker seconded. Motion carried 3-0.

- Assistant Chief Moore presented quote for Ventilation fans. These fans would not be gas powered as it puts toxins into the homes and takes longer for the ventilation. Donley Safety quote was \$4,795.00.
 5 Alarm Fire and Safety quote was \$3387.00. Donley Safety did not have exchangeable batteries which would be needed. Mayor York moved to table. Director Barker seconded. Motion tabled.
- Building Inspector Melton presented a curb cut for 2935 Legion Drive after tabling it on the last meeting. After inspection of the property everything met criteria. Director Barker moved to approve. Mayor York seconded. Motion carried. 3-0.
- Street Superintendent Walker asked Attorney Harvey to look at the toter fund ordinance and see if we could purchase plastic dumpsters with those funds. 15 new dumpsters are needed.
