Councilman Guffey: Noted;

Vice-President Hancock: Noted;

- Inquired about an ordinance for retention ponds and do they have to have a fence around them. Director Barker will try to see if there is an ordinance in place for that or not.
- Requested to have the stop sign in the middle of Main and Indiana could be moved. Trucks with trailers are having trouble turning and getting around the sign. It was agreed on by all, that they would remove the stop sign in the middle of the road on Tuesday morning.

- Thanked Fire Chief Moore for inviting all the Council Members into meet with him and educate them on where he would like to see our fire department move forward to.
- Stated that he is seeing more and more piles of shrubs around town. Councilman Walden said that he thinks it is getting a little out of hand on how big the piles have become. Street Superintendent Walker stated the piles should be no bigger than four foot high and four foot wide and not longer than 10ft.

ADMINISTRATIVE REPORTS:

- Director Barker advised Council for the completion of the Police Department the generator came in at 150,000.00. They will also need a building to store the Bearcat in as it will not fit in any of the bays in the building with a cost of approximately \$49,000.00 and would like to put a roof over the gas pumps which would be a cost of approximately \$27,000.00. Barker stated it would likely take another \$300,000.00 to complete the paving and everything.
- Clerk Treasurer Grider advised Council that under the Advisement of State Board of Accounts, that we should consolidate all the utilities bank accounts into one account. We have several accounts in two banks and it would make balancing all the accounts much easier and we would not have to be doing transfers from one account to another every day. President Peckinpaugh stated to get with Attorney Harvey and have him get something written up
- Administrative Assistant Kendra Kennedy stated that Corey Murphy with the EDC dropped of a pamphlet that she had passed out for all Council to see.
- Superintendent Walker stated, that he was approved to be a trainer for in house only CDL training. They would still have to go and take the test somewhere else but could be trained by Mr. Walker.
- Mayor York stated 4 employees had tested positive for Covid in one department. They would be temporarily shut down until the quarantine periods are over. Please wash your hands. Covid is becoming a normal way of life, so please take all the necessary precautions.


