Mayor York opened this meeting at 5:30pm.

Mayor York asked if there were any corrections or additions to the minutes of the former meeting. Dave made a motion to accept the minutes from the former meeting. Second by Sandy. Motion passed (3-0)

OLD/NEW BUSINESS

Patty opened the meeting with the opening of the sealed bids for Osborne Park. The Park Board requested (2) bids, one for the fencing and one for the infield, The results are as follows:

Fencing- 1. K & K Fencing- \$165,000.00

2. Oler Fencing- \$181,400.00

Infield- 1. J & D Turf- \$93,628.89

Further discussion followed on the bids and Osborne Park. Dave made a motion to approve the lowest bid for the fencing project (K & K Fencing) in the amount of \$165,000.00 with Sandy seconding. Motion passed (3-0)

Dave also made a motion to approve the lowest and only bid for the Infield (J&D Turf) in the amount of \$93,628.89 with Sandy seconding. Motion passed (3-0)

Mike will follow up with each company to finalize all specs and signatures required. The deadline for these projects is March 15, 2023.

Patty noted that the Courier Times featured an article recently of the Parks and it was nice to see how far we have come as an administration and all we have accomplished.

The Pickleball Courts are completed the final total was \$12,500 which came out of the maintenance budget. The Disc Golf is coming along with help of the parks department, Mayor York, Mike and Patty Broyles and others lending a hand to complete the set up.

The tree removal is in process at the park and again another thank you to the City Council for the ARP Funds to make this possible.

The Skate Park project is still in the works but has been scaled down due to funding. We should have new renderings soon from Hunger with the revisions.

The park shelters and the pool were a success for rentals this year and the board agreed to keep the fees the same in the coming 2023 year. These are amenities our community needs to continue to enjoy without a rate hike.
