

**ORDINANCE NO. 3898**

**AN ORDINANCE ADJUSTING THE AMOUNTS OF REVENUE  
ALLOCATED TO THE NON-REVERTING TRASH CONTAINER  
REPAIR AND REPLACEMENT FUND**

WHEREAS, the City of New Castle has, through § 95.30 of the City Code, imposed fees for the collection of trash and garbage; and,

WHEREAS, the City has previously adopted Ordinance 3827, which created a Non-Reverting Trash Container Repair and Replacement Fund ("Fund") and allocated the sum of two dollars and fifty cents (\$2.50) from the monthly fee for the collection of trash and garbage to the Fund; and,

WHEREAS, the City has determined that it currently has a sufficient number of replacement trash containers, and that the Fund contains a sufficient amount of revenue to purchase additional replacement trash containers; and,

WHEREAS, the amount of revenue from the monthly fee for the collection of trash and garbage that is allocated to the Fund should be reduced.

NOW THEREFORE BE ORDAINED BY THE COMMON COUNCIL of the City of New Castle, as follows:

1. Effective January 1, 2023, the sum of one dollar and fifty cents (\$1.50) of the amount received from the monthly fee for the collection of trash and garbage shall be allocated to the Fund.
2. Effective June 1, 2023, the sum of fifty cents (\$.50) of the amount received from the monthly fee for the collection of trash and garbage shall be allocated to the Fund.
3. All other provisions of Ordinance 3827, which are not expressly modified by the terms of this Ordinance, shall continue in effect.

**REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon passage.
