

**ORDINANCE NO. 3900**

**AN ORDINANCE AMENDING PRIOR ORDINANCES  
REGARDING THE SCHEDULE OF CHARGES FOR THE  
EMERGENCY AMBULANCE AND TRANSPORTATION SERVICE**

WHEREAS, the City of New Castle has by the passage of prior ordinances established rates and charges for the emergency ambulance and transportation service; and

WHEREAS, the charges have most recently been amended by Ordinance No. 3866 and codified at Section 33.26 of the New Castle City Code; and,

WHEREAS, it has been determined that an additional charge should be added to the schedule of charges.

NOW THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE, INDIANA that Schedule 33.26, and all other ordinances establishing charges for the emergency ambulance and transportation should be and are hereby amended as follows:

| 5. | Specialty Care Transport                     | \$2,000.00                  |
| 6. | BLS Non-Emergency                            | \$800.00                    |
| 7. | BLS Emergency                                | \$950.00                    |
| 8. | ALS-Intercept for other<br>ambulance service | Contracted rate or \$500.00 |

2. All other provisions of Section 33.26 of the New Castle City Code and Ordinances No. 3416, 3539, 3569, 3594, 3712 and 3866, which are not modified by this Ordinance, shall remain in full force and effect.

**REPEALER:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SEVERABILITY:** Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

**EFFECTIVE DATE:** This Ordinance shall become effective immediately upon passage.
