

**ORDINANCE NO. 3471**

**AN ORDINANCE LIMITING PARKING ON REDDINGDALE DRIVE**

WHEREAS, the Common Council of the City of New Castle has the duty to provide for public health, safety and welfare of its citizens, and

WHEREAS, the Traffic Committee of this Council after due consideration and investigation has determined that parking should be limited to the east side of Reddingdale Drive and all parking on the west side thereof should be prohibited.

NOW THEREFORE BE IT ORDAINED by the Common Council of the City of New Castle that no parking shall be permitted on the west side of Reddingdale Drive between Broad Street on the south and Spring Street on the north.

IT IS FURTHER ORDAINED that Chapter 75 Schedule I(A) of the New Castle City Code shall be amended by adding the following:

STREET: Reddingdale Drive

SIDE: West side

LOCATION: From Broad Street on the south to Spring Street on the north, every day, no exceptions

IT IS FURTHER ORDAINED that those who violate the provisions of this ordinance shall be subject to fine pursuant to New Castle City Code Section 72.99(b)(2) and having their vehicle towed at their cost pursuant to Section 72.99(k) of the New Castle City Code.

IT IS FURTHER ORDAINED by the Common Council that the New Castle Street Department shall post no less than three (3) signs on the west side of Reddingdale Drive between Broad Street and Spring Street, which notify drivers of this parking prohibition.

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed. Those provisions of the New Castle Code of Ordinances not in conflict with the provisions of this Ordinance shall remain in full force and effect.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage and publication and posting as set forth above by the New Castle Street Department.
