ORDINANCE NO. 3473

AN ORDINANCE AMENDING CHAPTER 92 OF THE NEW CASTLE CITY CODE

WHEREAS, the New Castle City Code Chapter 92 Sections 92.01 through 92.06 deal with civil emergencies, and

WHEREAS, this chapter of the New Castle City Code has not been updated or amended since its creation prior to the codification of 1980 City Code, and

WHEREAS, since September 11, 2001, the Department of Homeland Security of the United States Government and the State of Indiana have made many changes and improvements in the way cities deal with civil emergencies, and

WHEREAS, it has recommended to the City of New Castle that it update its Civil Emergency Procedures and more specifically Chapter 92 of the New Castle City Code, and

WHEREAS, it is the intent and duty of the Common Council of the City of New Castle to do all it can to protect the general health, safety and welfare of the citizens of this City.

NOW THEREFORE BE IT ORDAINED by the Common Council of the City of New Castle that Chapter 92 of the New Castle City Code be amended by repealing the current chapter and replacing it with the attached Exhibit "A" entitled "Chapter 92. Civil Emergencies". Said attached Exhibit "A" is hereby incorporated within the body of this ordinance and made a part hereof.

IT IS FURTHER ORDAINED by the Common Council that this chapter shall be updated and changed periodically as amendments and additions are suggested by the State of Indiana and the United States Government.

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed. Those provisions of the New Castle Code of Ordinances not in conflict with the provisions of this Ordinance shall remain in full force and effect.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage and publication.
