ORDINANCE NO. 3396
AN ORDINANCE ESTABLISHING CERTAIN FEES FOR
THE NEW CASTLE SOUTH MOUND CEMETERY
AND WEST LAWN ADDITION THERETO

This is an Ordinance creating and/or adjusting certain fees currently or to be charged by the New Castle Cemetery Department to those receiving services in the South Mound Cemetery or the West Lawn Addition thereto. This Ordinance New Castle City Code Section 9.01(B).

WHEREAS, Section 9.01(B) sets certain fees for the New Castle South Mound Cemetery and its West Lawn Addition, and

WHEREAS, it has been determined that certain new fees need be established and others need to be adjusted.

IT IS THEREFORE ORDAINED BY THE COMMON COUNCIL OF THE CITY OF NEW CASTLE as follows:

A. The following lot price shall be added to Section 91.01(B)(1) of the New City Code.

(a) Infant sites will be priced at \$100.00.

(b) Each gravesite will be priced at \$500.00 if purchased prior to death of interred (pre-need). If the lot is purchased after death, (immediate need) it will be priced at \$525.00.

B. Section 91.01(B)(2) shall be changed and hereby is amended as follows:

Opening and closing fees.

- (a) i. In-ground burial:
 - \$525.00 Opening and closing (during Monday-Friday normal work hours)
- ii. \$875.00 (Saturday opening and closing)
- iii. \$975.00 (Holiday opening and closing)

- (b) i. In-ground cremations:
 - \$225.00 Opening and closing (during Monday-Friday normal work hours)
- ii. \$525.00 (Saturday opening and closing)
- iii. \$675.00 (Holiday opening and closing)

C. The following additions or alternations to I.C. 91.01(B)(3) are hereby adopted:

- (a) Adult dis-internment: \$800.00
- (b) Infant dis-internment: \$400.00
- (c) Saturday burials: \$350.00
- (d) Burials after 3:30 p.m.: \$200.00
- (e) Deed preparation: \$ 5.00
- (f) Deed duplication fee: \$ 5.00
- (g) Police escort fee: \$ 35.00
- (h) Location of foundations: \$ 35.00
- (i) Location of government marker: \$ 15.00
- (j) Opening and closing on holidays: \$450.00

Any provision of the New Castle City Code Section 91.01(B)(1), (2) and (3) not changed by this Ordinance shall remain in full force and effect. All changes hereto including additional fees shall apply to both the South Mound Cemetery and the West Lawn Addition thereto.

REPEALER: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SEVERABILITY: Any provision herein contained which is found by a court of competent jurisdiction to be unlawful or which by operation shall be inapplicable, shall be deemed omitted but the rest and remainder of this ordinance, to the extent feasible, shall remain in full force and effect.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon passage and publication as provided for by law.
