Attorney Copenhaver informed Mr. Wilkinson that when title search was done by the city, he was not listed as an owner. After discussion Mr. Wilkinson stated he was not aware his contract should be recorded. Mayor York moved to table and allow Attorney Copenhaver to review the information. - O Brock Taylor, representing YMCA, requested permission to use the pool for their pre-school in the mornings as in the past as well as reserve Baker 1 for every Friday in June and July. - Clerk Treasurer York presented rate quotes for review and award and a draft Resolution to be presented to Council for the lease purchase of 9 Police vehicles and 10 White Department Trucks.
